## 4. Purpose and legal basis of the data processing

## 5. Categories of the personal data processed

The following categories of personal data will be processed:

- Address and contact data
- Name, title, academic degree
- Information on contracts and invoice processing
- Bank details for the remuneration of services rendered
- Information on the contact history
- Information in connection with project deployments in case of a contractual handling via GULP

as well as comparable data.

## 6. Source of data

Your data has been collected by the Controller directly from you or the data originates from third parties (end customer or intermediate service provider (Managed Service Provider)).

## 7. Recipient or categories of recipients of personal data

The Processors appointed by the company include cloud service providers, other companies of the group (<https://www.randstad.de/ueber-randstad/randstad-gruppe-deutschland/unternehmensgruppe>), providers of services essential to the corporate services to be provided, such as companies providing IT services, experts and consultants.

## 8. Transfer of personal data to a third country

The data may be transmitted to countries within and outside the European Economic Area, in particular also to the U.S.A. The company will take appropriate and adequate security measures in accordance with the applicable data protection laws to protect the data or the data transfer.

## 9. Period for which personal data are stored

Once collected, your data will be stored for as long as is required for compliance with the statutory retention periods which apply to the relevant tasks.

## **10. Rights of data subjects**

According to the EU General Data Protection Regulation (GDPR), you have the following rights:

If your personal data is being processed, you have the right to obtain information about the data we collected about you (Art. 15 GDPR).

Should incorrect personal data be processed, you have the right to rectification (Art. 16 GDPR). If legal requirements are met, you can demand erasure or limitation of processing and object to processing (Art. 17, 18 and 21 GDPR).

If you have given your consent to data processing or there is a data processing contract and data processing is carried out using automated procedures, you may have a right to data portability (Art. 20 GDPR).

If you make use of the rights mentioned above, the Controller will check whether the legal requirements are fulfilled.
